## Notice to Competitors/Local Rules-Potowomut GC

Tee Markers: Men play from: White Tees / Women play from: Red Tees

**Immovable Obstructions Close to the Putting Green**: Relief from interference by an immovable obstruction may be taken under Rule 16.1. The player also has these extra options to take relief when such immovable obstructions are close to the putting green and on the line of play: For a Ball in the General Area. The player may take relief under Rule 16.1b if an immovable obstruction is: On the line of play, and is:

- Within two club-lengths of the putting green, and
- Within two club-lengths of the ball, and
- When the ball and obstructions are in part of the general area cut to fairway height or less.

Exception – No Relief If Line of Play Clearly Unreasonable. There is no relief under this Local Rule if the player chooses a line of play that is clearly unreasonable. Penalty for Playing Ball from a Wrong Place in Breach of Local Rule: General Penalty under Rule 14.7a."

<u>Cart path extensions</u>: Areas not marked, which are extensions of cart paths are deemed to be part of the path. Fellow competitors must be notified before taking relief.

<u>All French drains</u> throughout the course are obstructions.

**Flower Beds and Ornamental Planting Areas**: Treat as Ground Under Repair. Flower beds and ornamental plantings within paved areas and adjacent to cart paths are considered part of the obstruction.

<u>Course boundary</u>: Stone wall on holes 1, 4, 6, 8, 10, 12, 14, 15 & 17, a ball is out of bounds when it comes to rest over the wall. White Stakes/Painted white line: Inside edges of white stakes are deemed to be boundary except when painted white line is present, white line defines boundary, on holes 5, 6, 11, 12, and 15. Chain Link Fence: on hole 17, inside edge of fence poles are deemed to be boundary.

<u>Hole 15:</u> The course boundary to the left of the green is defined by stone walls – Area between the 2 stone walls, the boundary is defined by a painted white line. Inside the boundary is a lateral (red) penalty area – For a player to proceed under <u>Rule 17</u> (Penalty Areas) the player and fellow competitors must be *virtually certain* that the ball is in the penalty area, if not the player must proceed under <u>Rule 18</u> (Ball Lost or Out of Bounds).

<u>Stone Walls and Foundations on Holes #13 & #14</u>: Ball drops are provided as an additional option under Rule 24 for interference for stance, area of intended swing **and line of play intervention**. Proceed to ball drop designated for play of each hole.

Hole #18: Driving range is in The General Area.
